The township is looking for a new cleaning crew. Please look at the ad for cleaning and apply if you qualify.



## MONEE TOWNSHIP HIGHWAY COMMISSIONER'S REPORT

This past winter brought cold temperatures but limited amounts of snowfall. Despite the smaller amounts of snow, the windy conditions caused drifting which caused additional plowing and salt spreading. The road district used around 300 tons of treated road salt this winter.

We installed blinking solar stop signs at the intersection of Pauling Road and Harlem Avenue. This intersection has experienced numerous serious accidents over the years. The hope is that the blinking lights will help the stop signs to better be seen and



Our salt supplier has informed us that next year's salt prices could be much higher because most of our salt comes from Canada. They are not sure how much if any tariffs will increase the cost.

As we welcome Springtime please be aware of farm equipment on the roads and slow down when you encounter them. An extra minute of your time is worth staying safe for you and the equipment operator. Wishing everyone a pleasant and safe spring and summer!

#### **EMERGENCY ASSISTANCE**

- Emergency Assistance is available to persons:
  - Who are eligible for GA
- Who are not receiving categorical assistance or SSI Who face a life-threatening situa-
- tion due to loss of income, medi-cal emergency or other unusual circumstances and
- Who meet the other financial and non-financial eligibility criteria
- Who have lived at their address for six (6) months or longer.

You may receive EA up to a maximum established by the Township only once in a 12-month period. EA is paid directly to a provider (such as a landlord or utility company) to alleviate the life-threatening situation

A written application for EA must be filed with the Township. The Township will determine whether you are eligible for GA within 30 calendar days of the date you file your application. How-ever, every effort will be made by the Township to make a decision within ten business days of receiving all needed paperwork. For more information, please contact the Township at 708-534-6020.

#### FOOD PANTRY

The Township operates a Food Pantry to provide food on a temporary basis to persons in immediate need. Foodstuffs will not be provided to supplement food stamps or on a long-term basis. Applicants are asked to apply for food stamps before receiving foodstuffs a second time. Donations are accepted year-round for the Food Pantry.

#### **OTHER PROGRAMS**

The other programs the Township provides are Thanksgiving, Christmas, Easter Basket and School Supply programs. The Township accepts donations for all programs. For more information about these programs, contact the Township Office.

#### **RECORDING YOUR DD-214**

Your Service, Your Benefits: Safeguard Them The Report of Separation contains information normally needed to verify military service for benefits, retirement, employment, and membership in Veterans organizations. Information shown on the Report of Separation may include the service member's:

Date and place of entry into active duty

Home address at time of entry

Date and place of release from active duty

Home address after separation Last duty assignment and rank

Military job specialty

Military education

Decorations, medals, badges, citations, and campaign award

Total creditable service

Foreign service credited

Separation information (type of separation, character of service, authority and reason for separation, separation and re-enlistment eligibility codes).

How do I record my DD-214 in the County Recorder or Registrar's office?

Bring in your DD-214 paperwork after your separation date shown on your paperwork.

Bring in a picture ID

Make sure that you record your DD-214 in a convenient county. A county where you will remember the location

Recording your DD-214 as well as getting copies and certified copies are free, so please ask for what you will need when you visit the office

Currently, you may make appointments for office visits that require some research in preparation for your visit, but for most situations, you will be able to walk in and get assistance without having an appointment for help, especially with exemptions and assessment reviews. Email is still the preferred method of contact, as this is the best way to reach the Assessor directly at moneeassessor@gmail.com. In addition to email, we will continue responding to voicemails if you leave your phone number to set appointments to assist you, if necessary. We still have stations established with sneeze guards in 3 locations for assistance inside our office. There will be a limit of 3-5 people inside the office simultaneously except for workshops or exemption events.

Will County Supervisor of Assessments (SOA) Updates

I scheduled meetings on multiple occasions in 2024 with the SOA to request exclusion of rehabs and updated properties from the factor calculations derived for the Sales Ratio Study. I have been making ongoing requests to exclude the 2024 rehabs, non-market sales and some new constructions and now am providing candidates for exclusion from 2025 sales. When this is done it will lower the 2025 factor as well as the 2026 factor. I will keep you informed of the results.

#### The 2024 Pre-Appeal assessment review process worked well

This year 2025, we are continuing to offer a Pre-Appeal option for residential property assessment reviewed based on the last 3 years sales. If your property assessment falls below 1/3 of the median sales price for your neighbor-hood, then your value is supported. But if your property assessment is higher than 1/3 of the median sales price for your neighborhood, after the factor was added, then your assessment is a candidate for reduction accordingly. Please submit the information or form to our email monee-Prease submit the information or form to our email monee-assessor@gmail.com or you will be able to pick up a form to complete and drop off for your request after June 1, 2025. We were able to help get reductions for most of the residen-tial property owners submitting their request in 2024. So do not hesitate to contact us so your property assessment can be reviewed for adjustment, if needed. This will continue to be an ongoing process until we start to see a leveling off of the factors after the Rehabs have been removed the factors after the Rehabs have been removed. Exemptions will save \$\$ on your tax bills

Q: Did you know that exemptions saves \$\$ on tax bills? A: The Monee Township Assessor's Office assists with the completion of a variety of exemptions that are offered to **decrease** your tax bill! Exemptions are described here: The General Homestead Exemption is determined at the time of sale, based on the indication on the Sales document (PTAX) as the buyer's primary residence. No other action to be taken.

Additional Exemptions that decrease taxes include:

- Senior Exemption (must be 65 years or older) - Senior Freeze (based on a household income of \$65k or less)

- Disabled Persons' Exemption (SSI, Doctor's statement or 2A ID)

- Home Improvement Exemption (additions or upgrades)

Check your tax bill for exemptions to see if you have all that is due to you. If you are not sure which exemption you should have on your property or what your current exemptions are, then call us during office hours and someone will be able to assist you in obtaining this information. Do you know anyone 65 years or older? Have them contact us ASAP to verify that they have their senior exemptions.

## **Disabled Veterans' Homestead Exemption**

This exemption allows a veteran with a serviceconnected disability (SCD) of at least 30% that was issued by the U.S. Department of Veterans Affairs to receive an exemption that reduces their assessment. These Exemptions are renewed annually and the amounts are shown below:

- If the veteran has experienced a SCD ranging from 30%-49% will receive an exemption of 2,500
- If the veteran has experienced a SCD that ranges from 50%-69% will receive an exemption of 5,000.
- If the veteran has experienced a SCD of 70% or greater, a 100% exemption from taxes is granted. If the veteran is 100%, total and permanently disabled then no renewal submission is required.

#### Q: How does assessments relate to taxes?

A: The Assessor's office is responsible for applying fair assessment for the entire township. When assessments go down, the rates usually go up and when assessments go up, then the rate tends to go down, this allows the taxing bodies to receive at least what they received the previous

year in their levy to meet their budget and is usually up to 5% increase.

Q: What are the activities that affect your tax bill? A: 1. Each year your assessment will be adjusted by the Will County Supervisor of Assessment (SOA's) factor. Assessment increases do affect your tax bill. Often when assessments go up, then the rate tends to go down, and as a result, people with the Senior freeze exemptions may actually see savings.

2. Then your taxing bodies, like school boards, villages, township, county and others will request a levy amount to fulfill their budget needs for the year, and that also affects your bill. The levies are generally limited to the consumer price index (CPI) amount, used by the county clerk. Please note that many taxing bodies in Monee Township who are getting tax \$\$ from University Park did increase their % requests in a range from 30-50% due to closing of UP TIF 5. This may also make a significant increase to all properties in University Park portion of Monee Township.

3. When appeal decisions are made by the Board of Review to lower the assessment for an appellant, this affects all taxpayers that did not receive a reduction since the assessment base is lowered because of granting reductions.

4. Finally, applying exemptions to your bill will result in savings in your taxes,
